

I found the wording difficult to keep track of. I like books with lots of illustrations and salient bullet points at the end of the chapter, this book has none of that. occasional illustrations after pages and pages of solid text blocks. I also prefer when books have extended table of contents that show each subtopic under the main topic either on the main TOC or at the beginning of the chapter for ease of reference- this doesn't have that. Lastly, I'm not sure if i missed it but there is some coding? or abbreviations in the chapters and I have no idea what they refer to

Gives a good general review of ortho. If you are new to ortho or looking for a very general overview this is a pretty good one. Easy to read and usually pretty well edited. The peds section is a little lacking. While it does go over the basics of treatment it really doesn't go into surgical techniques, exposures or other surgical points.
