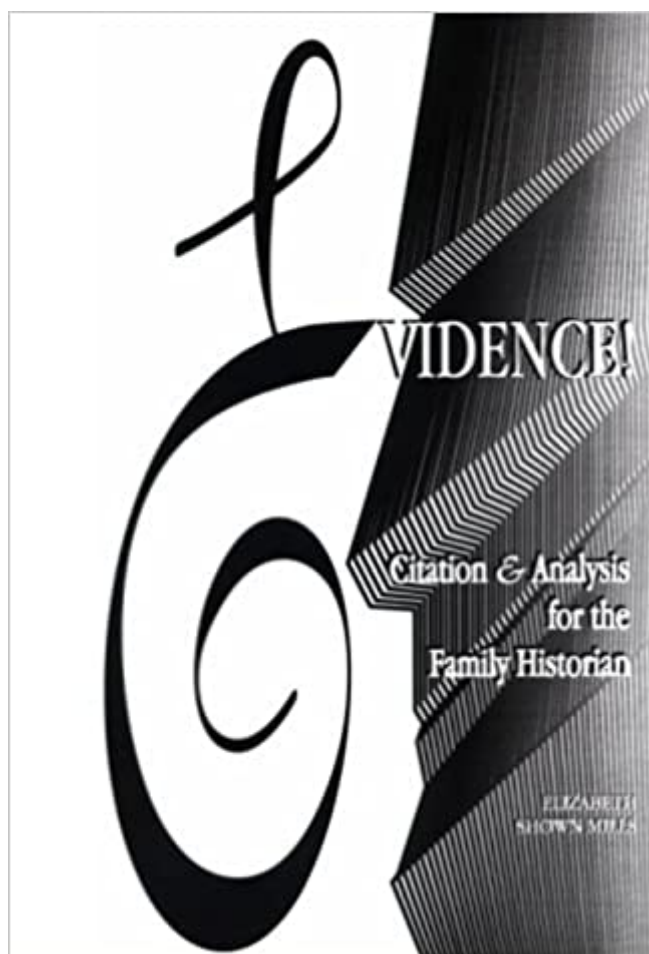

I felt frustrated trying to find how to do a particular citation because the index did not differentiate the various subclasses of citations within a given class very well.
