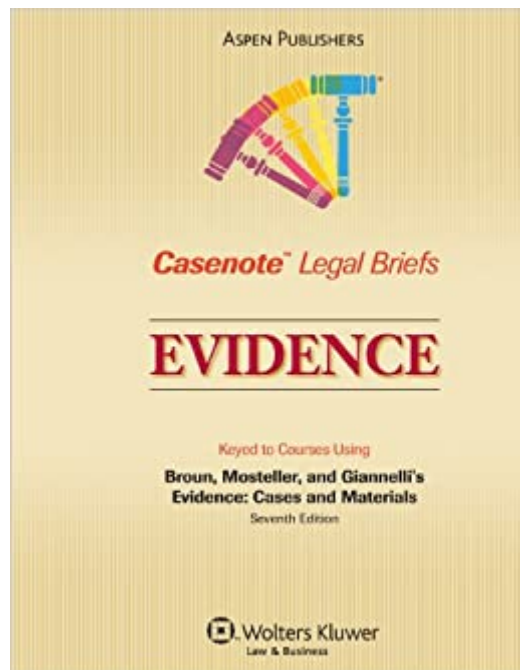

Really helpful book for the Gianelli book. Gave thorough case briefs for each case and most of them hit all the major points. A few of the case briefs focused on obscure things and missed some of the more important, substantive content, but, overall, this is a quality product.

Of course, this thing is essential for Evidence. Keep in mind though, it is for a previous edition, so there are some cases missing. Also, the summaries seemed to miss some key points in favor of pointing out surface rules. Last, there were a surprising amount of typos.

This case brief book is excellent. It is keyed to my actual case book and does a nice job of explaining each case and the law with brevity. I highly recommend this book.
