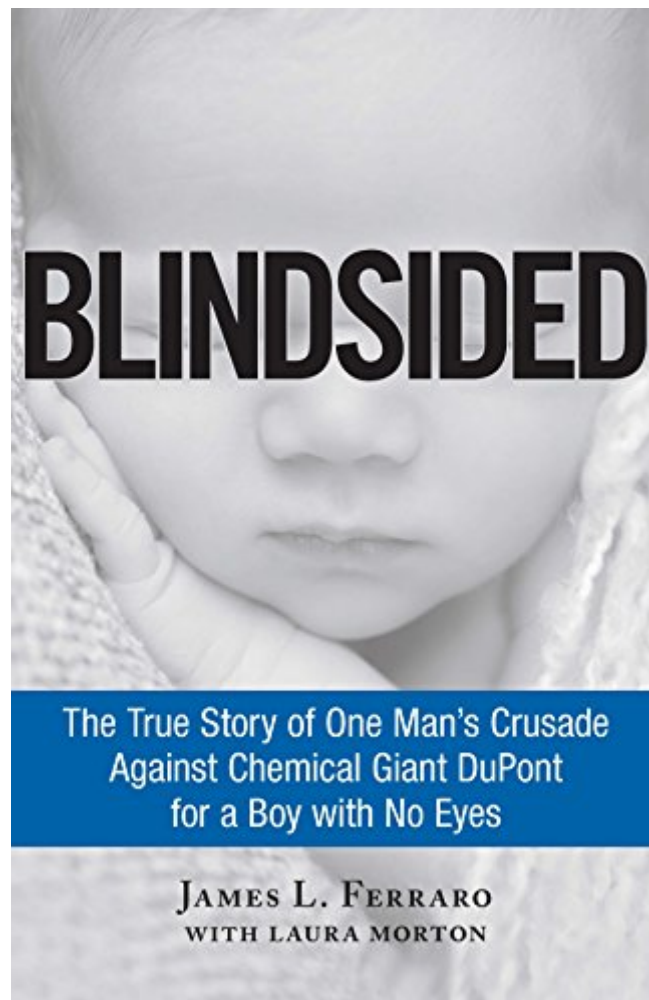

Given the state of \*regulation\* (Ha!) these days, the justice system is our last best hope for recourse. Until these poison purveyors are forced to absorb the true costs (environmental, personal/public health) of their products, we (society) are going to continue to pay the price. I thank God for the judges and trial lawyers who hold these pesticide makers somewhat accountable.
