

Bryan Garner divides the book into lessons that provide short but meaningful lessons in various aspects of legal writing. The part I use the most is the appendix with common uses and misuses of punctuation. I highly recommend law school students purchase this book before their first semester, even if it is not listed by any professor.

I don't think I've ever written an review before, but this book is simply too good not to contribute to the meager seven reviews it has received. In this book, Garner has amassed simple and straightforward way to improve legal in a humorous and easy-to-read book. Hardly any of the brief suggestions weren't helpful and his writing is so good that I would actually find myself continuing to digest them long after I intended to stop. The fact this isn't a foundational text for every 1L entering law school is criminal.
