

# **Synopsis**

In 1886, the discovery of rich goldfields in the Klondike precipitated a flood of gold-crazed men and women rushing north to the Yukon territory. From tragic tales of the Lost Patrol and the "Mad Trapper," to curious murders, to dramatic search and rescue missions by dogsled, behind the iconic Canadian Mounties are real people with enthralling stories that require no embroidery.
