

This was a truly excellent introductory textbook on computer security. I would especially like to praise "Module A," the appendix section which teaches the basics of computer communication from the ground up. This was a great way to gain a thorough understanding of basic-level network traffic, which builds a solid foundation from which readers can understand the rest of the material. The chapters are long but thorough, with useful and interesting case studies peppered throughout. The

boom is written on a level such that a person with a basic Bachelor's-level education in another field can understand the concepts even without a technical background in computers. As this is a textbook, I suspect most purchasers will be buying it because they are required to for a course. Just let this review serve as notice that you are, indeed, getting your money's worth.

I just started my MS in Information Management and this textbook was required for my first class. I recommend renting this textbook instead of buying it. Trust me on this one.
