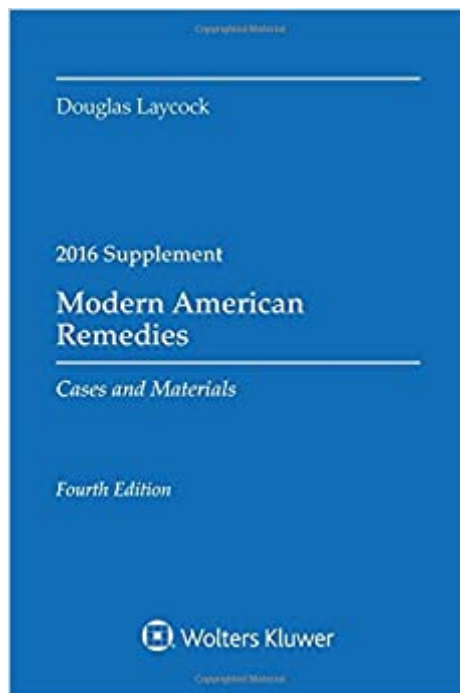

Although the link to this text indicates in title it is the "concise" edition - when I purchased it used there was no such indication. I am now 2/3 into my semester taking Remedies and have gotten to the point where I am missing an entire chapter of case law! The one case in a section is not in the full version either.
