

The introduction by Frances Fox Piven, a well-known progressive social scientist, argues that it will only be through the organized action of social movements that a fuller menu of rights is likely to be made available to ordinary Americans. The volume is organized topically around different classes of rights (for children, women, and indigenous peoples). Each essay is short, to the point, and accompanied by a bibliography.
