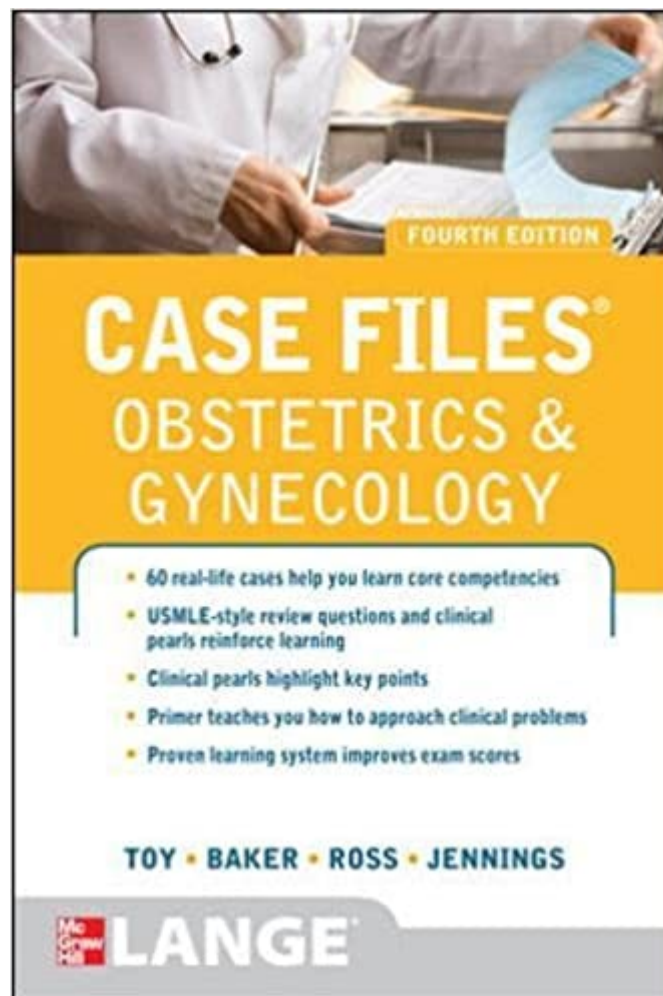

Awesome book, definitely a must read while on the Clerkship. Aced my shelf exam which according

to my peers was one of the hardest exams during 3rd year. When I asked them if they studied with case files they all said no. Very complete, and has just enough depth without getting over the top crazy like blueprints. I used the kindle version and it works great. I didn't have any problems it was just as easy to navigate as having a book in your hand.

Good book. Errata: the new guidelines for active phase of labor is $\geq 6\text{cm}$ dilated, whereas this book is outdated and still recommends 4cm. Not nitpicking, it's on the shelf and all the Qbanks, so it's definitely something you need to know. Otherwise, as usual, CaseFiles is awesome. ALL the cases are awesome. Maybe a definition or 20 extra that we don't need to know but still, it's there for completeness sake. Wish I could give it 4.5 stars, because it's not quite 5, but is a little better than 4. FYI For the shelf do the ACOG/Uwise questions x2, this book x1 and you should easily honor it. Oh, and UWorld of course.

This is the best book for your OB/GYN shelf exam (NBME). The chapters in this book essentially cover all of the high-yield topics. Of course I would encourage you to try practice questions from UWorld or the NBME website. I crushed my shelf exam and I couldn't have done it without this book. If you're on an audition rotation, you should have this book with you!

I studied 95% from this book for my shelf and did very well. Everything you need is in here and you can supplement with UWorld or questions from the ACOG website. Great study tool.

Great book! Read it a couple times through the rotation along with ACOG uWise questions and you'll get a high score on the SHELF exam and be able to answer most questions you'll get asked during your rotation.

The only case files you should buy for 3rd year medical school, super helpful. Get the newest edition for a few minor things that have changed.

Don't expect to smoke your shelf exam if this is your only reference, but if you aren't going into OB/GYN and just need a decent reference, this is a good one. I read a few cases a day over the clerkship and answered all the questions after each case. I spent 1 day going through questions on a popular Qbank and passed the exam very comfortably.

Super easy to read. Highly recommend. Got an A+ on my shelf because of how well I knew this book. Carry it around with you and read a few cases each day when you are on call or during your break. By the end of your rotation, you are ready to Ace that test.
